It's also available if you're a WA resident stationed outside of the state. Institutions of higher learning in WA will also be taking greater strides to recognize and provide academic credit for some of your military training. Funding for education, training, and employment opportunities have been extended, as well as opportunities for developmental disability and retirement home services, **Veteran's designation** on drivers' licenses, and more.
