Lt Col David C. Alvarez is currently the Deputy Chief of the Nuclear Policy and Sustainment Branch, Nuclear Integration Division, Directorate of Logistics, Installation, Mission Support and Nuclear Integration, HQ Air Force Materiel Command, Wright-Patterson AFB, OH. He is responsible for the integration of nuclear policy and nuclear sustainment processes throughout the command. He integrates nuclear equities with several cross-MAJCOM working groups to include; Supply Chain Risk Management (SCRM) working group, Electromagnetic Pulse (EMP) working group, and nuclear education and training working group. He crafts policies for NWRM, SCRM, EMP testing, nuclear education, and key nuclear billet manpower allocations.

Lt Col Alvarez enlisted in the Air Force on 30 May 1995 and he attended technical training at Sheppard AFB, TX, as a dental technician. He served his enlisted career in the 92 Dental SQ at Fairchild AFB, WA, before being selected to attend a 2 year AFROTC program at Washington State University in 2001. Lt Col Alvarez commissioned as a Second Lieutenant in 2003 as a Logistics Readiness Officer. Over his 16 year officer career he has served in a variety of logistics readiness assignments with experience in the LRS, Aerial Port, MAJCOM Staffs, and joint expeditionary environments. Prior to his current position, Lt Col Alvarez was the Director of the Logistics Directorate, HQ AFOSI, Quantico MCGI, VA.
